What are the current primary health challenges facing the Philippines, and how is the Department of Health addressing them?

The current primary health challenges facing the Philippines were first revealed during the COVID-19 pandemic. Issues in health infrastructure, processes, and human resources for health are the focus of the Health Sector 8-Point Action Agenda (8-PAA), which, in turn, lies at the core of the National Objectives for Health (NOH) 2023-2028, the government's medium-term strategy to strengthen the health sector.

For a developing country like the Philippines, prevention of illness is the key to better health outcomes and lower healthcare costs. Hence, we focused on improving the delivery of primary health care, where patients receive comprehensive and coordinated health services. Primary healthcare is effective in the prevention and early management of diseases before they become more complicated or severe. Thus, strengthening primary health care, which is at the heart of Universal health care, can reduce overcrowding in hospitals and make quality healthcare more accessible and affordable.

To ensure that no one is left behind in the provision of quality healthcare, we intensified our individual- and population-based interventions to maintain and protect health and well-being. We are continuously implementing the Health Facilities Enhancement Program (HFEP) which constructs Primary Care Facilities (PCFs) in all provinces. We also launched other programs that would bring healthcare closer to the people. These include the establishment of Bagong Urgent Care and Ambulatory Services (BUCAS) Centers, operated by DOH hospitals, offering preventive, diagnostic, and curative primary care services. They are convenient and accessible one-stop shops for patients seeking health services. BUCAS Centers may soon be operated on a 24/7 basis, and will be the catalyst to link the rest of the Health Care Provider Network (HCPN). We also deployed Bagong Pilipinas Mobile Clinics, which will complement the capacity of existing health facilities and, with their mobility, reach more patients in remote and underserved areas.

What are the DOH's strategies in terms of collaborating with international organizations and other sector stakeholders to improve health outcomes in the Philippines?

The DOH collaborates with international organizations and other sectors through various initiatives.

- Through memberships in different multilateral and regional bodies like the WHO, ASEAN, UN, APEC, Gavi, and other international organizations, we are able to get support through funding, technical assistance, capacity building for our health workers, and access to essential medicines and vaccines. There is also easier coordination with other countries and other organizations especially during pandemics and health emergencies.
- By forging bilateral/multilateral agreements or cooperation with other countries, we foster our diplomatic relations, agree on areas of cooperation for implementation, share health data and best experiences to improve health systems, conduct health research, and provide technical assistance.

The National Objectives of Health (NOH) 2023-2028 strategy is anchored on "AmBisyon Natin 2040." How does promoting good health contribute to the broader goals of economic and social transformation outlined in this long-term vision?

The NOH 2023-2028, the health sector's medium-term strategy, is anchored on and aligned with our long-term vision and medium-term plans, "AmBisyon Natin 2040" and the Philippine Development Plan (PDP) 2023-2028, respectively. The NOH emphasizes promoting UHC as essential to achieving economic and social transformation. Ensuring equitable access to quality healthcare services upholds Filipinos' fundamental right to health.

Healthy individuals are more productive, contributing to economic growth. Preventive care reduces healthcare costs, freeing up resources for education, infrastructure, and social services. Access

to healthcare enhances overall well-being and life satisfaction, leading to a more stable and content society.

A strong health system improves resilience to health crises, ensuring minimal disruption to economic and social activities. Healthy children perform better in school, laying the foundation for a skilled and knowledgeable future workforce. Addressing social determinants of health, such as working and living conditions, ensures people can lead healthier lives.

By promoting UHC, the NOH 2023-2028 strategy supports the vision of "AmBisyon Natin 2040". This integrated and holistic approach to health and development is key to sustainable economic and social transformation in the Philippines.

Establishing a robust monitoring and evaluation framework is crucial for the NOH 2023-2028. How does the DOH plan to track and assess the progress of the health sector's medium-term strategy?

The health sector's medium-term strategy monitoring, evaluation, accountability, and learning (MEAL) system is being developed to provide guidance on the quantitative and qualitative dimensions of the 8-Point Action Agenda (8PAA) performance towards the realization of its key strategic objectives.

The MEAL system shall form the basis for the assessment of annual progress, as well as a structured framework for evaluating the agenda's achievements by the conclusion of this administration in mid-2028. The adoption of the MEAL system underscores the Department's commitment to stakeholder accountability and emphasizes the utilization of learning points from the 8PAA implementation for continuous quality improvement in the health sector. It shall also foster a culture of learning, ensuring a sustained effort to enhance decision-making processes for subsequent agenda development.

The DOH is tasked with facilitating capacity-building programs for local government units. Can you elaborate on the types of programs and workshops that will be implemented to enhance local healthcare capabilities?

Development of Handbook for Local Health Boards

- The DOH, in coordination with the Department of the Interior and Local Government (DILG), DOH Centers for Health Development (CHD), Union of Local Authorities of the Philippines, Association of Municipal Health Officers of the Philippines, Provincial Health Officers Association of the Philippines, and Sanggunian Council Chairman for Health created a program to develop the Handbook for Local Health Boards (LHBs), which will serve as a governance reference for the LHBs such that it could fully support the Local Government Unit's (LGU) journey towards Universal Health Care (UHC). LHBs, composed of representatives from the LGU at several levels, from the DOH, and from the private sector, were formed under the UHC Act of 2019.
- This handbook will serve as a crucial resource, outlining good practices, procedural steps, and strategies for overcoming common challenges towards the functionalization of LHBs.

Capacity Development Program for DOH Representatives

- The first module (technical) and practicum for DOH representatives working with the LGU was piloted to the DOH Representatives of SOCCSKSARGEN Center for Health Development in 2023-2024. In 2024, DOH will continue its partnership with PBSP to develop and pilot Module 2 (leadership), the Facilitators' Guide, and the actual Training Manual in preparation for its national rollout in 2025.
- These DOH representatives serve to provide technical and managerial assistance to the LGU through the Local Health Boards and in other capacities that might be needed as the LGU transitions towards Universal Health Care.

Tingog Partylist, Roche (Philippines) Inc. sign pact to help educate, screen, diagnose, treat women with breast, cervical cancer

- **Tingog Partylist and Roche (Philippines) Inc. have signed a memorandum of agreement (MOA) to advance the 2030 Mission Leapfrog Project (MLP), a collaboration of Roche and health ecosystems partners to accelerate transformation in healthcare outcomes for women affected by breast and cervical cancer.**
- **Through the MOA, the Tingog-Roche partnership supports the goals of the National Integrated Cancer Control Act (NICCA) and the Universal Health Care Law (UHC) as it aims to advance breast and cervical cancer education, screening, diagnosis, and treatment to support women in key MLP sites.**

“Our partnership with Roche (Philippines) Inc. signifies a pivotal step towards realizing this vision. Roche’s global expertise in healthcare innovation, combined with Tingog’s deep understanding of the local landscape, creates a powerful synergy. Together, we are poised to make significant strides in improving the diagnosis and treatment of breast and cervical cancer, thereby enhancing the quality of life for countless individuals,” Rep. Romualdez said.

“Today marks a significant leap forward in our shared commitment to transforming health care outcomes, particularly in the realm of breast cancer and cervical cancer,” Rep. Acidre said.

“Mission Leapfrog embodies a noble mission to accelerate the journey towards improved healthcare systems, focusing on the pivotal experiences of breast and cervical cancer patients. This initiative aims to revolutionize the landscape of women’s health,” he added.

“We thank Tingog Partylist and Reps. Yedda Romualdez and Jude Acidre for partnering with us in ensuring teachers, mothers, daughters, pillars of our society have access to life-saving medicines and diagnostics,” said Dr. Edralin, who is also President of the Pharmaceutical and Healthcare Association of the Philippines (PHAP).

“We also thank House Speaker Ferdinand Martin G. Romualdez for helping us at Roche address the anxiety and confusion around breast and cervical cancer and empower women to take charge of their health through better education and prevention, and lessen the fear of the financial impact of cancer through government and private funding support,” added Dr. Dioko.

Under the collaborative agreement, Tingog and Roche will help advance breast and cervical cancer education, people gathering, diagnosis, and treatment support for the women in the Mission Leapfrog LGU sites, as they champion policies supporting cancer program prioritization and funding.

Roche will also bring in partners from various stakeholders who will support and develop the MLP, and help map out avenues to care and financing to minimize the out-of-pocket expenses of patients.

Apart from helping provide access to mammogram and breast ultrasound services to high-risk women identified by the Mission Leapfrog Program, Tingog will also help provide funding support for breast and cervical cancer diagnosis and cancer treatment.

MANILA - To raise awareness of breast and cervical cancer and boost the capability of the government to give care and treatment to more women nationwide, Tingog Partylist and Roche (Philippines) Inc. signed a Memorandum of Agreement (MOA) on May 8, 2024 to advance the 2030 Mission Leapfrog Project (MLP).

The MOA cements a private-public sector partnership in support of the goals of the National Integrated Cancer Control Act (NICCA) and the Universal Healthcare Law (UHC), as 2030 Mission Leapfrog aims to improve healthcare outcomes in the Philippines, specifically those for breast and cervical cancer, through components such as education, screening, diagnostics, and treatment accessibility.

The parties formally signed the memorandum at the Office of Tingog Partylist at the House of Representatives in Quezon City through **Tingog Partylist Rep. Rep. Jude Acidre; Dr. Diana Edralin**, General Manager of Roche (Philippines) Inc.; and **Dr. Ma. Teresa Dioko**, Healthcare Ecosystems Chapter Lead of Roche (Philippines) Inc.

With the MOA, Tingog and Roche hope to speed up the transformation of healthcare outcomes in the country by improving the referral system from screening to treatment, through the lens of a breast or cervical cancer patient and through key partner local government units (LGUs).

“With this agreement, we mark the beginning of a transformative journey with the 2030 Mission Leapfrog Project,” said **Tingog Partylist Rep. Yedda Marie K. Romualdez** in her message delivered by Rep. Acidre.

“At the heart of Tingog Partylist’s mission is a steadfast commitment to championing the health and well-being of our people. Our core agenda has always been focused on fostering healthcare development that directly benefits the lives of those we serve,” she added.

The discussion also highlighted potential areas for further collaboration, ensuring that the practicum program continues to offer valuable real-world experience to the students while supporting the

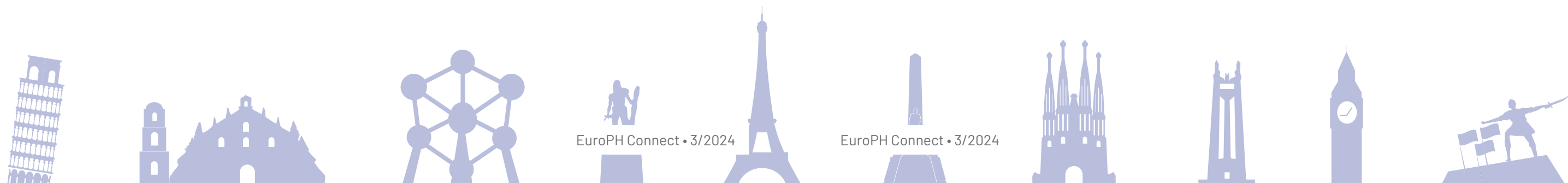

We hope that this venture would pave the way for a better future for HR solutions in the Chamber.



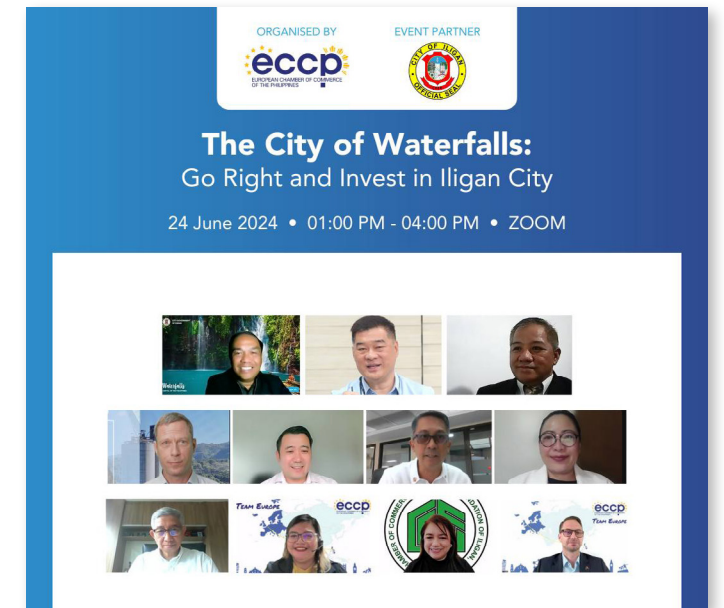

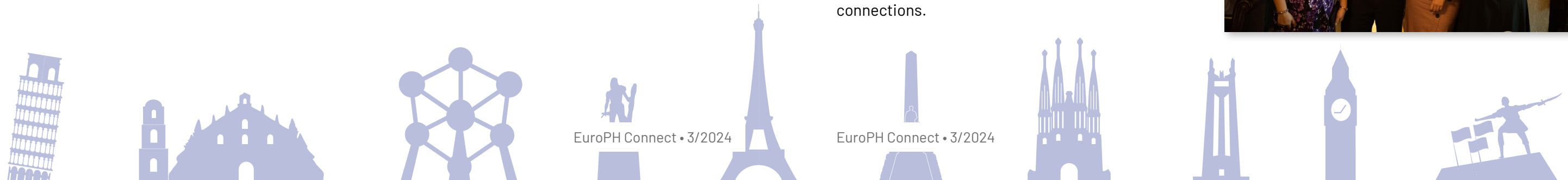

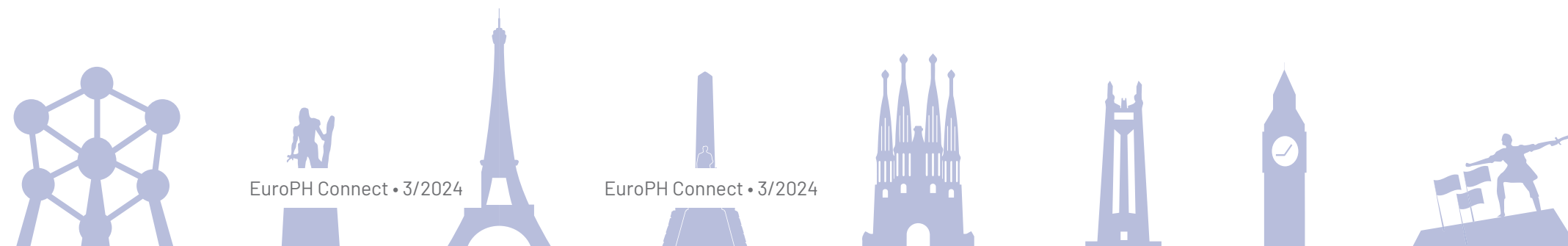
ECCP joins DCIPC Davao Stakeholders Meeting

Bureau of Customs Grand Launching of the ATA Carnet System 15 July 2024

The ECCP attended the Grand Launching of the ATA Carnet System last 15 July 2024. ATA Carnet, also known as passport for goods, is an internationally accepted customs document to temporarily import and export goods into over 80 carnet countries and territories, allowing cross-border movement of goods duty- and tax-free. In the Philippines, the ATA Carnet System will be implemented on 15 July 2024 for the following: 1) commercial samples; 2) professional equipment; 3) and good for display at exhibitions, fairs, and meetings.

The Philippines is the 81st country to implement the ATA Carnet. This shall expand opportunities for industries and further facilitate cross-border trade and investments. The Philippine Chamber of Commerce (PCCI) is the duly authorized National



Issuing and Guaranteeing Association (NIGA) in the Philippines. Carnet validity shall not exceed one (1) year from the effective date of the security furnished to PCCI.

During the event, the BOC also officially signed a Customs Memorandum Order, implementing the ATA Carnet across the Philippines.

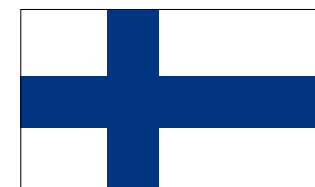
